Awarded \$10,000 fellowships to 30 students for a year of graduate study. Awarded 15 \$1,000, 266 \$2,000, and 1 \$3,000 scholarships to 288 engineering seniors. 6 college freshman received \$1,000 for engineering study. \$7,000 in scholarships were available to students selected by 14 chapters.

Publications

Published a quarterly magazine with a circulation of over 90,000 for members. Features include news of the Association, chapters, and members and articles on engineering. Also published an online newsletter on college activities and leadership information with a circulation of 11,000 engineering juniors and seniors.

Convention, District, Engineering Futures, MindSET, Greater Interest in Government (GIG)

Held national and regional meetings of its members where collegiate chapter officers receive leadership training, professional development, and chapter operations training. Students receive training in possible service activities including tutoring students, counseling high-schoolers, training K-12 math and science students, and providing volunteers and funds to other charities. Grants included \$833.96 to support K-12 STEM and GIG projects in local school districts across the country.
